Principal's Report: Tracey Barton

- Been so busy getting the kids back face-to-face and they continue to make decisions as the next wave of students return face-to-face after spring break.
- April 19th is the date for the second wave of kids returning to face-to-face learning.

- It has been recommended, not required, that if you travel for spring break, you and your family quarantine for 10 days
- 2 of the special teachers in our building are traveling to a couple other schools to help with the face-to-face specials.
- Kids being back face-to-face has been going well and no big issues so far. Recess is going especially well because the kids have such respect for their teachers and you don't have so many kids all together at one time.
- Stem room can hold up to 2 more classes if needed when the second wave of students return.
- Final phase of tearing down old Donley is in the works as soon as the school year ends. There will be an updated bus loop, covered parking, and playground.
- Looking into solar power issue and where it should go.
- The delayed drop off and pick up have been working well to reduce the amount of students entering and leaving the building at one time.
