School Board – Kate Powers (Board Rep)

The Board is working diligently on the Bond Proposal. The Vote date is May 2. The Board will voting on School of Choice slots for the upcoming year – the are looking at 92 slots for choice students in grades K through 5. The Board is looking to stay stable with their enrollment.

The Board had a retreat last evening and had a lot of conversation re:communication.

A question about permeable boundary requests was asked. The Board will be looking at the issue of permeable boundaries and it is on the agenda of the policy committee.

DPC/Fundraising Reports - Alex

Ginger Ogilvie was at the meeting. She was discussing the Safe Routes initiative. Every school will be getting a walking rope and will ideally have remote drop off points where parents can drop their kids off and then they

can all walk to school. October 4 will be walk to school day and there will be a Walk and Roll Safety day on April 30.
