Under the direct supervision of the building Principal, and in accordance with the established policies and procedures of the East Lansing Public School District, the High School E2020 Credit Recovery Teacher for the ELPS Summer Program is responsible for monitoring and supporting students during online credit recovery classes in a variety of subjects. Must be technologically savvy and able to navigate and troubleshoot minor tech or software problems. As a member of the summer school staff, the teacher has responsibilities in the areas of instruction, classroom management, student relations, family and community communication.

1. Facilitates students' motivation for learning by communicating enthusiasm for online courses.
2. Provides for a safe, efficient, and organized learning environment.
3. Assesses and evaluates students effectively:
 - Provides meaningful, formative feedback to students, and uses the information to monitor and adjust instruction daily.
 - Develops and prints a summative report for student progress and at the conclusion of the course, providing a written report to parents and administrator.
 - Monitors E2020 site daily to provide assistance to students.
 - Proctors online final exams accordingly.

5. Communicates effectively, both verbally and in writing, with students, families, and administrators.
